The United Arab Emirates welcome visitors from all over the world and in order to achieve the strategic objectives that support the government's direction in providing the best electronic and smart services to all customers in the country, the Ministry of Interior offers a service of recognition and exchanging of driving licenses within "Markhoos" initiative, which allows the UAE citizens to drive with their national license in different countries around the world and exchange it for the purpose of residency. The initiative also grants visitors of the UAE the right to drive with their national driving licenses and exchange it with an Emirati license for the purpose of residency by the following conditions.

***** Terminology:

- **Recognition:** Use of the United Arab Emirates national driving license **not** for the purpose of residence.
- Exchange: Exchange of United Arab Emirates national driving license for the purpose of residence only.

- **5.** Categories to be exchanged: According to the regulations and categories specified in the United Kingdom competent authority.
- **6.** Pass the required medical examination.
- **7.** Comply with other necessary requirements to exchange driving licenses (if any).

Republic of Austria

- 5. Pass the required medical examination.
- **6.** Comply with other necessary requirements to exchange driving licenses (if any).

Israel

Republic of Azerbaijan

- 4. Fulfill the minimum age requirement laid down by national legislation of Republic of Azerbaijan .
- 5. Categories to be exchanged: Motorcycles (Category A A1) & Automobiles not belonging to (A) category, the maximum allowable weight of which is not more than 3,500 Kg and the number of seats which is not more than 8 in addition to the driver's seat, and Automobiles of B category with trailer with maximum allowable of 750 Kg , but not more than unladen weight of Automobile and with such composition, the maximum allowable weight of which is not more than 3500 kg in whole, A driver license certifying the right to category (B) is acceptable for vehicle belonging to sub- category (B1).
- 6. Pass the required medical examination.
- 7. Comply with other necessary requirements to exchange driving licenses (if any).

- UAE's citizen should use international driving license in the countries that are not mentioned within above list.
